I WANT ALL POLICE REPORTS BY EITHER STAFFED CLERGY OR BY VOLUNTEER LAITY OF CHURCHES. THE DATE, TIME, PERSON REPORTING, UNREDACTED CONTENT OF THE ALLEGATION(S) OR COMPLAINT(S) OR COMMUNICATIONS TO POLICE REGARDING ME.

What happened to cause you to have contact with the police?

HOPE CHURCH IN WORCESTER CONFIRMED EXISTENCE OF A POLICE CASE REFERENCE NUMBER BY THE CHURCHES. ANGLICAN VICAR RICH JOHNSON OF ALL SAINTS CHURCH IN WORCESTER CONFIRMED HE HAD SPOKEN TO POLICE ABOUT ME, PRIOR TO MY VISIT ON SEPT.24 2017 TO HIS CHURCH. ALL SAINTS CHURCH RANG THE POLICE UPON MY VISIT SEPT.24 2017. A LAITY OF WOODGREEN EVANGELICAL CHURCH IN WORCESTER SAID ON SEPT.24 2017 THAT HE WOULD REPORT ME TO POLICE. ANGLICAN ARCHBISHOP JUSTIN WELBY AND HIS BISHOPS AND CLERGY OF WORCESTER CATHEDRAL CONTINUALLY REFUSE TO COMMUNICATE A SPECIFIC ACCUSATION AGAINST ME, OR TO JUSTIFY THEIR BANISHMENT AGAINST ME.

(THERE EXISTS NO REALITY-BASED OR SUBSTANTIAL REASON. FROM BEGINNING TO END, THE CLERGY'S PHYSICAL ASSAULTS, EVICTIONS, BANISHMENTS AND FALSE ACCUSATIONS IS ENTIRELY THE PRODUCT OF THEIR OWN LIES AND FANTASIES. IN THEIR MINDS, THEY PERCEIVE A TORSTEN-THE-MONSTER.)

Hello,

It came to my attention on Oct.29, 2017 that the churches in Worcester are reporting lies against me to the West Mercia Police. Since then, I have attempted to seek further information and "justification" for the lies fabricated against me by the church clergy, and to which I understand has been reported to the West Mercia Police.

I would like to know the case reference number and a copy of the false report against me, invented by the pastors and priests of the churches in Worcester.

JOHN ANONYMOUS: Well, I suppose that my secret plan is that there is a police case from previous occurrences where you're forced to leave. So, push comes to shove I would contact the police.

TORSTEN: Ok, would you like to do so.

JOHN ANONYMOUS: No. I don't want to do so.

TORSTEN: Why not? By the way, what's the current police case?

JOHN ANONYMOUS: Again, I have no idea but I have their reference.

TORSTEN: Their reference? Well, would you like to tell me the reference? You have their reference.

JOHN ANONYMOUS: It's a number.

TORSTEN: It's a number. Hm. Ok. Is it a case reference?

JOHN ANONYMOUS: Yes.

TORSTEN: Ok. Can I have it?

JOHN ANONYMOUS: I imagine you know about it already? For having been in trouble with the police before.

TORSTEN: No actually I don't. I don't know the case number.

JOHN ANONYMOUS: Is it going to help you to know it?

TORSTEN: I want to investigate it. I want to find out what lies you have invented in that report.

JOHN ANONYMOUS: Well I haven't invented any lies. This is a police case presumably in Worcester from other churches.

In my quest to expose the intentional lies and slander fabricated by the pastors and priests of the churches in Worcester, I have in email correspondence with Lambeth Palace of the Church of England ([http://www.kyrkor.be/All-Saints-Church Worcester UK Anglican- eviction 2017.htm](http://www.kyrkor.be/All-Saints-Church_Worcester_UK_Anglican- eviction_2017.htm)) requested an explanation. Of course, because the Church of England knows fully well that they are responsible for lying against me, they will never respond with an answer to the question:

The question:

Church of England, what specific sin, immorality or wrongdoing or "behaviour" do you accuse against Torsten, justifying your excommunication/banishment and your eviction?

I hereby request that West Mercia Police will promptly email to me a pdf copy of the report(s) made against me by the churches in the West Midlands.
